🔀 INSTALLATION NOTES

- (A) Actuators with appliance cables are numbered.
 - V Provide overload protection and disconnect as required.

Actuators may be connected in parallel. Power consumption and input impedance must be observed.

- Actuators may also be powered by DC 24 V.
- S Only connect common to negative (-) leg of control circuits.
- A 500 Ω resistor (ZG-R01) converts the 4...20 mA control signal to 2...10 V.

A One built-in auxiliary switch (1x SPDT), for end position indication, interlock control, fan startup, etc.


Meets cULus requirements without the need of an electrical ground connection.

Apply only AC line voltage or only UL-Class 2 voltage to the terminals of auxiliary switches.
