



Actuators with appliance cables are numbered.

Provide overload protection and disconnect as required.

Actuators may also be powered by DC 24 V.

6 Only connect common to negative (-) leg of control circuits.

 Λ A 500 Ω resistor (ZG-R01) converts the 4...20 mA control signal to 2...10 V.

Actuators may be connected in parallel if not mechanically linked. Power consumption and input impedance must be observed.
