Actuators may be connected in parallel. Power consumption and input impedance must be observed. Actuators may also be powered by 24 VDC.


Actuators Hot wire must be connected to the control board common. Only connect common to neg. (-) leg of control circuits. Terminal models (-T) have no-feedback.




