





Flow/Mounting details









(A) Actuators with appliance cables are numbered.

- \setminus Provide overload protection and disconnect as required.
- Actuators may be connected in parallel. Power consumption and input impedance must be observed.
- $\sqrt{5}$ Only connect common to negative (-) leg of control circuits.
 - Δ A 500 Ω resistor (ZG-R01) converts the 4...20 mA control signal to 2...10 V.
 - Meets cULus requirements without the need of an electrical ground connection.
