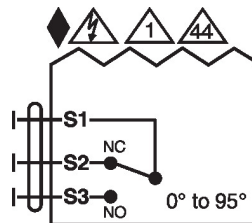
- (A)** Actuators with appliance cables are numbered.
- (1)** Provide overload protection and disconnect as required.
- (2)** Actuators may be connected in parallel. Power consumption and input impedance must be observed.
- (3)** Actuators may also be powered by DC 24 V.
- (5)** Only connect common to negative (-) leg of control circuits.
- (7)** A 500 Ω resistor (ZG-R01) converts the 4...20 mA control signal to 2...10 V.
- (44)** One built-in auxiliary switch (1x SPDT), for end position indication, interlock control, fan startup, etc.
- ◆** Meets cULus requirements without the need of an electrical ground connection.
- (⚠)** Apply only AC line voltage or only UL-Class 2 voltage to the terminals of auxiliary switches. Mixed or combined operation of line voltage/safety extra low voltage is not allowed.
