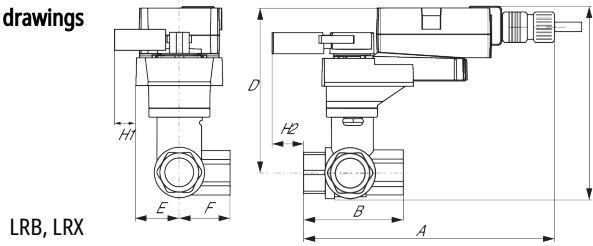

Flow/Mounting details



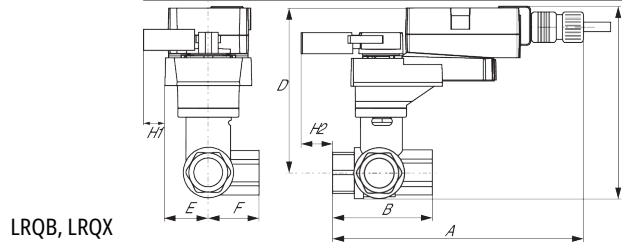

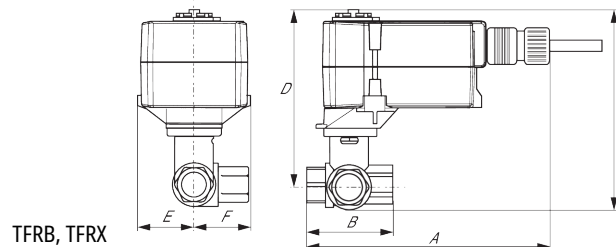
