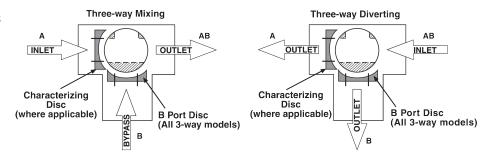




Flow/Mounting details





Actuators may also be powered by 24 VDC.




Actuators with plenum cable do not have numbers; use color codes instead.
