- Actuators may also be powered by 24 VDC.
- Only connect common to negative (-) leg of control circuits.
- A 500 Ω resistor (ZG-R01) converts the 4...20 mA control signal to 2...10 V.
- Actuators with plenum cable do not have numbers; use color codes instead.
- Meets cULus requirements without the need of an electrical ground connection.
